

SOSA Dance Fitness Instructor Completion Process

Congratulations on completing your SOSA Dance Fitness Online Instructor Training Course!

We will get back to you with a final decision if you have passed the course within 72 hours of submitting your practical assessment video (or your Skype assessment).

If you have successfully passed the course, your SOSA Dance Fitness Instructor Academy access will be granted as soon as your Completion Certificate and Instructor Licence Certificates have been issued.

If you do not achieve some or all of the assessment criteria and receive a ‘referral’ assessment decision, you will be given feedback and an action plan to enable you to prepare to re-take the assessment. We will have an in-depth conversation with you about which sections of assessment we had concerns with and be told how to rectify the points we have made. We will do our best to help you through it, and give you as much support as you need.

We may ask that you go away and practice the assessment routine some more, and then re-record your assessment routine and send to us, so that we can reassess the elements we had concerns with. In some cases, there will be a specific time frame within which you must re-take the assessment. Once we are satisfied that you have answered our points your certificates will be forwarded to you and you may start teaching.
